#### **Mission of Salem Presbytery**

Salem Presbytery connects, supports, and strengthens local congregations and worshipping communities to carry out Christ's transformative work of love and justice in the church and in the world.

#### **Salem Presbytery Land Acknowledgement**

A Land Acknowledgement is a formal statement that recognizes the unique and enduring relationship between Indigenous Peoples and their traditional territories; laying plain that Indigenous people have not been and cannot be erased.

Further, to recognize the land is to express gratitude and appreciation to those upon whose traditional territory we reside, and it is a way of honoring the Indigenous people who have been living and working on this land for centuries.

A land acknowledgement does not exist in a past tense, or historical context alone; colonialism is a current and ongoing process, and we need to build mindfulness of our present participation in that arrangement. It is also worth noting that acknowledging the land is Indigenous protocol.

North Carolina has been home to many Indigenous peoples at various points in time, including the tribes/nations of: Bear River/Bay River, Cape Fear, Catawba, Chowanoke, Coree, Creek, Croatan, Eno, Hatteras, Keyauwee, Machapunga, Moratoc, Natchez, Neusiok, Pamlico, Shakori, Sara/Cheraw, Sissipahaw, Sugeree, Wateree, Weapemeoc, Woccon, Yadkin, and Yeopim.

The State of North Carolina currently recognizes 8 tribes: Coharie, Lumbee, Meherrin, Occaneechi Saponi, Haliwa Saponi, Waccamaw Siouan, Sappony, and the Eastern Band of Cherokee.

Salem Presbytery is situated on lands originally inhabited by the Cherokee, Tutelo, Saponi, Saura, Keyauwee, Sissipahaw, Occaneechi, Eno and Tuscarora, if not other peoples.

So today, let us acknowledge those peoples whose ancestors were stewards of this land for many years before the arrival of European Settlers. Their descendants are still here and have a historic and essential bond to the physical space of North Carolina. They, and the land itself, are integral to our past, present and future.

Let this acknowledgement serve as an ongoing reminder of our collective stewardship, in partnership with the original inhabitants, of the land where we reside.



Greetings Commissioners to the February 11 Meeting of Salem Presbytery.

Please share this communication with your Elder commissioners to the upcoming Presbytery meeting on Feb. 11, 2025, as it pertains to our voting on the proposed amendments to the Book of Order from the 226<sup>th</sup> General Assembly.

The proposed amendments to the Book of Order have been reviewed by appropriate committees within Salem Presbytery. As our commissioners for the Feb 11 meeting of Salem Presbytery prepare to vote on these at the meeting, it may be helpful to know what our committees recommend for each. Our committees took great care and spent intentional time in discussion of each proposed amendment. Although all of the amendments are recommended for a vote to approve, you will note that Amendment 24-C had a divided vote by both reviewing committees after much discussion. Please review each of these carefully in preparation for the Presbytery meeting. The Proposed Amendment Booklet is linked here for your convenience and includes background and advice from the General Assembly. In light of our committee recommendations, the Executive Council has suggested that Salem Presbytery handle our voting on these amendments in a way similar to how we have in the past. When you receive the Docket for the Presbytery meeting in a few weeks, most of the amendments (except for 24-C) will be included in an omnibus motion for efficient voting. These are the amendments that do not seem to require debate or discussion. Any of them may be pulled from the omnibus motion for individual consideration during the approval of the docket at the meeting if a commissioner desires. We will plan to vote on Amendment 24-C individually as well as any others which might be removed from the omnibus motion by request.



#### Dear Friends:

As we gather at North Wilkesboro Presbyterian Church this coming Tuesday, we note a number of issues that confront—and often confound—us as communities of Christ in these challenging and anxious times. I want this report to serve as a helpful resource to sustain and secure your respective ministries throughout our Presbytery.

#### Our Church as Sanctuary

A number of Presbytery members have expressed their deep concern about actions undertaken at the federal level which may disrupt their ministries and place at risk vulnerable members of their congregations and worshipping communities using their facilities. Among the most affected constituencies are non-US citizens who find themselves being subjected to possible detention. While there is no specific information indicating that Salem Presbytery churches are being targeted at the time of this writing, I think it wise that pastors, ruling elders, and other church leadership and staff be made aware of their rights should Immigration and Customs Enforcement (ICE) undertake any effort to access church facilities.

My executive presbyter colleague in Chicago Presbytery, Rev. Dr. Craig Howard, has compiled an exceedingly helpful and comprehensive list of resources for his presbytery's membership at <a href="https://chicagopresbytery.org/2025/01/27/immigration-resources/">https://chicagopresbytery.org/2025/01/27/immigration-resources/</a>, and I commend this list to you for your study and edification. Salem Presbytery staff are available to speak with anyone with specific concerns about their communities who may be in need of more local resources and advocacy.

#### 2025 Benefits Plan Now in Effect

As I have indicated in my letters to the Presbytery in Salem Matters, new Benefits Plan for 2025 is now in effect, and churches have now experienced their first month's billing cycle under the new plan. Once again, I strongly counsel church administrative personnel, pastors, and staff plan beneficiaries to review their monthly dues statements under the new plan and ensure that all information shown on the invoice is accurate.

We expect that the vast majority of due statements in our Presbytery will be correct and in accordance with understandings reached with all eligible pastoral leadership and staff, but it surely will not hurt to check. Even Salem Presbytery's January invoice revealed a small coding error that could have resulted in dues overcharges of \$11,000 if not addressed early in the year, so be forewarned that errors do occur especially given the substantive changes undertaken in 2025. As always, both the Board of Pensions member services staff, Regional Church

Consultant Elizabeth Little, COM Task Force on Benefits members, and I are available to assist you should you encounter issues in resolving your benefits billing for the year.

#### Long Haul Helene Disaster Recovery

Although the television cameras have left long ago and media attention has shifted to other disasters (prayers for Los Angeles firestorms and air crash victims in Washington and Philadelphia), our mountain communities continue to be front and center in our concerns for their recovery from the flooding occasioned by Hurricane Helene early last fall.

Our continued prayers and support continue for all our seven affected congregations in Ashe and Watauga, including, Baird's Creek, First Boone, Glendale Springs, Lansing, Laurel Fork, Mount Jefferson, and Rumple Memorial. If your church is interested in supporting the extensive disaster recovery efforts either now or in the future, please let the Presbytery staff know, and we can direct you to entities coordinating external resources in the recovery effort.

#### A Word of Appreciation

My husband, Michael, and I want to extend our deepest appreciation and thanks for the heartfelt and overwhelming expressions of sympathy and prayers offered following his mother's recent passing. Sandra Bendgen welcomed me into her family with enviable grace and love. Both she and my mother even traveled to the Pittsburgh General Assembly in 2012 to hear me preach before that august body. Michael and I hold her memory dear, and we are ever grateful to be a part of this community of Salem Presbytery that shares Christ's love so freely and openly. We are truly blessed beyond measure!


#### Salem Presbytery Matthew 25 Book Study

Many people are aware of the injustices Black Americans have suffered over the centuries but feel powerless when it comes to repairing the harm done.

The inequality remains even after laws and policies have been corrected. Calculating and implementing financial reparations will require large-scale government action, which can feel out of reach or overwhelming for the average person. Robert Turner provides an accessible guide for individuals and groups wanting to influence significant institutional action while also acting on their own to repair the effects of racial injustice in our communities, churches, and spheres of influence. Dividing into categories of individual, social, institutional, and spiritual repair, Turner offers the longest list of reparations currently published, with more than one hundred actions listeners can begin practicing and advocating for to help balance economic injustice, undo hurtful decisions from decades past, and rally public support for bold and principled legislation.



#### Salem Black Caucus Moderator's Report 12-14-2024

Greetings in the name of our risen Lord and Savior Jesus Christ!

Salem Black Caucus seeks to cultivate a vibrant, thriving community of Salem Presbytery African American Congregations empowered by visionary leadership, spiritual vitality, and transformative ministry.

We are also dedicated to revitalizing African American Congregations, by recruiting and nurturing energetic clergy, fostering congregational vitality through collaborative partnerships. The Salem Black Caucus strives to create resilient and flourishing church community that reflect the love of God.

The question then becomes, How Do We Get There?

This important conversation was started by the Synod of the Mid-Atlantic in 2023, and the Next Generation Initiative was created to focus on African American congregations and to start the conversation of the decline in AA leadership and membership. This decline is our current reality in several AA congregations.

The question has now become, How Did We Get Here and what are we going to do about it?

My hope is that Salem Presbytery, the Synod of the Mid-Atlantic and the PCUSA will continue to identify and nurture young Black leadership. I pray that the current African American Congregations will be refreshed and renewed and think outside the box as they witness in their perspective communities. The goal of the Salem Black Caucus is to align with the Synod of the Mid-Atlantic, Next Generation Initiative to systematically address the unique challenges facing African American congregations and invest in the development of Black clergy and lay leadership, breathing new life into churches and building vibrant, lasting communities.

The Black Caucus meets bi-monthly on the 2<sup>nd</sup> Saturday of that month from 10am-12pm. The African American churches are asked to pay yearly \$100 per church and pay for two elders at \$50 per elder to be Caucus members. All are welcome to attend the Salem Black Caucus bi-monthly meetings whether you are a paid member or not. The meetings are a hybrid model and are conducted in person and via zoom.

In 2024, the host congregations for the bi-monthly meetings included: Lloyd on August 17, 2024, new officers were elected, Trinity on October 12, 2024, the learning corner speaker was General Presbyter Tony De LaRosa, and Mebane 1<sup>st</sup> on December 14, 2024, the learning corner speaker was Designated Presbyter for Transformational Ministry, Jodi Lingan.

Peace and blessings to all, as we do the work that God has called us to do within Salem Presbytery, within our congregations and beyond. We will continue to have the spirit to serve with energy and be creative with our fellowship and worship.

The CPM offers the following report:

The CPM moves the following motion:

1. That Salem Presbytery examine Nolan Chilton, First Presbyterian Church of Burlington and a graduate student of Duke Divinity School, and that following his successful examination, he be enrolled as a Candidate for the office of Teaching Elder.

Nolan Chilton- Journey of Faith Statement

I vividly remember myself standing outside of FPC Burlington upon returning from a summer service trip to the local "Meals on Wheels prior to my sophomore year of High School. While waiting for my ride, I remember my youth pastor at the time approaching me and asking if I had an interest in being a Youth Elder and representing the youth group as an advisor in meetings. This was the moment for me that I felt my understanding of call begin. The thought that somebody within the church felt as if I would be a good fit to lead and wanted to hear what I had to say, shifted my experience of church and faith from something that I just did, because that was what everyone did, to something that became profoundly meaningful and a part of my identity. After this, I found myself increasingly involved in the life of the church, from asking my

parents to go on Sunday mornings even when we were not planning on going as a family, to constantly finding myself in the mix of whatever youth ministry opportunities were available to

me. It was through this increased exposure to the church that I truly felt like I was growing in faith and understanding. It was from this moment on, that I began to sense a call to a deeper involvement in the body of Christ.

When I left for college, I found myself wondering what the next step in my faith journey looked like in a place that was so unfamiliar to me. I bounced around from several different fields of study that I thought would point me in the direction of my future. In my time in sports science classes and communication classes, I couldn't help but my find myself utterly disinterested in the material. During this time of exploration, it always felt like I there was a calling to something more meaningful. Through conversations with professors, peers, and my church family back home, I came to recognize that God was calling me to ministry. Growing more dissatisfied with my current course of study, I finally met with my academic advisor. He shared with me a simple but profound thought, that "your field of study should meet at the intersection of what you're passionate about and what you're good at." For me, this instantly clicked. There is nothing at that time that I had felt more passionate about than my faith. The church was no longer just a place I had grown up; the church was where I was sharpening my faith and had found belonging. If what I am passionate about is my faith, then what does it mean to be "good" at it? Being someone who was raised in athletics, my mind synced that to be "good" at something is to practice it. This is when I began to embrace with God's calling of me towards ministry. To further explore this, I decided to pursue a theological education. Upon graduating from Catawba College, I was blessed with an oppurunity to serve at FPC Greensboro as their interim youth director. As someone who was wondering what their call looked like vocationally, the chance to serve in youth ministry was a gift of the Spirit. Serving at FPC Greensboro was an opportunity to answer God's call to serve the church in a way that had been extremely influential in my own journey. In that time, the spirit revealed to me a passion and a joy for youth ministry in particular. Since then, I have moved on and have been serving as the Director for Children and Youth at Mt. Bethel Presbyterian Church in Durham for 2 years while completing my M.Div. at Duke Divinity School. This time in ministry and discernment

among colleagues and classmates, has helped me to better understand my call. I feel that God is calling me, and the Spirit is moving me, to the work of youth ministry at this time. This calling has become evident to me through my faith in God, my care and hope for the younger generation, and my commitment to the work of the church. For me, being "good" at faith

means resting in my confidence in God, my calling, and my beloved-ness. It is through time spent in prayer and in discernment with the faith communities I have been a part of that my sense of calling has been shaped by God; by walking with others in their faith journeys, by seeing faith develop in their lives, and by ultimately joining them in knowing, trusting and believing in their beloved-ness also.

My prayer is now that, in this ordination process, I come to fully understand all the ways God is calling me into the ministry of the church and the world and finding the places where I can best and most effectively serve God's kingdom. I feel God calling me to ordination in the Presbyterian Church (U.S.A.) and I look forward to further discernment of this call through continuing education, working alongside my fellow Presbyterians, and seeking God in the world.



# NORTH CAROLINA PRESBYTERIAN PILGRIMAGE

"I am the way, and the truth, and the life. No one comes to the Father, except through me."

## Purpose

The purpose of the Pilgrimage movement is to inspire, challenge, and equip local church members for Christian action in their homes, churches and communities. By grace and with the Holy Spirit, we encourage leaders to discover and achieve their personal calling and provide them with a method for influencing their environment.

## History of the Pilgrimage

The Pilgrimage is an offshoot of the Roman Catholic Cursillo movement which began in Spain in 1949 and moved to America in the late 1950's. In addition to the Cursillo movement, there are similar expressions in the Methodist, Episcopal, Lutheran, and other Christian churches. Today, more than 8 million Christians in more than 60 nations have attended one of these 3-day weekends.

## What happens at a Pilgrimage?

Pilgrimage is not a retreat. The weekend is an opportunity through which one's spirituality may be developed, lived and shared in any area of human life where there are Christians willing to dedicate their lives to God's mission. During the 72 hours, Thursday evening through Sunday afternoon, 14 talks are presented. Five talks are given by pastors and nine by lay people. Following each talk, small round table discussions focus on the main point of the talk. The talks, in an overlapping fashion, present the Christian life, based on the Word of God and the person of Jesus Christ, as an ideal. Pilarimage gives those attending a living understanding of basic Christian tools and living a life in God's grace. The weekend also includes chapel each day, communion, music, singing, laughter, and prayer.



## Who May Attend

Pilgrimage is an ecumenical movement for Christians who desire a closer relationship with Christ. Guests may be any denomination. A Pilgrimage is not designed to convert anyone to Christianity. It is meant for those who are already faithful and committed to Christ and His church. The goal is to encourage Christians in their faith walk by increasing their awareness of grace and their desire to serve Christ, the church and the world.

## Can L Attend A Weekend? How Much Does It Cost?

If you would like to attend a Pilarimage weekend, please contact an individual who has previously attended to serve as your sponsor. We suggest you also speak to your pastor, when you decide to attend. If you do not know anyone who has previously attended a weekend, we will be happy to provide you with additional information or answer any questions that you may have. ## What Happens After A Weekend?

The weekend is only the beginning. Your local congregation and community will benefit from what you've learned and shared over these three days. You will be encouraged by many others who have attended to share the Christian life of grace in community.

NCPP is a non profit self-supporting program operated by lay volunteers under the NCPP State Leadership Council. The state organization includes three conferences — each with its own officers - in Piedmont, Eastern, and Western North Carolina.
