It is the responsibility of the PNC Commission on Ministry Liaison, in coordination with Presbytery staff, to ensure this material is received in a timely manner. The Faith Journey and Personal Statement of Faith (<u>SEE INSTRUCTIONS HERE</u>) should be one page each with your name in the header.
